TERMS AND CONDITIONS OF USE

Preamble

The purpose of these terms and conditions of use (hereinafter "TCUs") is to define the terms and conditions of use of the " le défilé Renault " website (hereinafter "Website").

Access to and use of the Website implies unreserved acceptance of the TCUs by the User.

Article 1 – Definitions

For the purposes of this document:

"Website" refers to the " le défilé Renault " website published by RENAULT, providing access to the Elements. The Website includes Content, software, programs, tools (programming, navigation, etc.), databases, operating systems, documentation and all other elements that make it up, as well as updates and new versions that RENAULT may make of the Website.

"Content(s)" refers to, but is not limited to, the structure of the Website, editorial content, drawings, illustrations, images, photographs, graphic charters, brands, logos, acronyms, company names, audiovisual works, multimedia works, visual content, audio and sound content, as well as any other content present on the Website.

"Elements" refers to the various functionalities and items of information offered on the Website.

"Renault Group" means Renault S.A.S. and any entity controlled by, under shared control with or controlling Renault S.A.S., directly or indirectly, and includes any entity jointly controlled, directly or indirectly, by Renault S.A. and a third party.

"Participant" means a natural person of legal age taking part in events organised by Renault S.A.S..

"User" means an individual of legal age browsing the Website for his or her own needs, for strictly personal and non-commercial purposes, with no direct or indirect profit motive.

"Vehicle" means any vehicle of one of the Renault Group brands.

Article 2 – Purpose of the Website

The purpose of the Website is to enable Users as per the following:

Le défilé Renault is a venue that presents the Renault 5 E-Tech electric to the general public.

The venue is open from September 1st at 53 avenue des champs Elysées PARIS.

A website, https://yourevent.renaultgroup.com/defile_renault/index.html, enables the general public to register for events organised by Renault in the above-mentioned location.

To book their participation in an event, the user must register via a form on the https://yourevent.renaultgroup.com/defile_renault/index.html website.

People who have booked onto an event will receive a confirmation email via their email address.

To take part in events reserved for adults, participants must:

- Register using the form on the https://yourevent.renaultgroup.com/defile_renault/index.html website
- Adhere to the booking schedule
- Carry proof of identity
- Provide the registration confirmation email at the entrance

To take part in events reserved for people under the age of majority, participants must:

- Register using the form on the https://yourevent.renaultgroup.com/defile_renault/index.html website, stating the number of children taking part

- Not mention children's first or last names in comments
- Adhere to the booking schedule
- Be in possession of an identity document for the accompanying adult
- Provide the registration confirmation email at the entrance
- Be aged between 3 and 12, depending on the type of workshop
- Wear sportswear for the sports workshops

This list is non-exhaustive and may be modified at any time by Renault without any liability on its part.

Article 3 – Access to the Website

The Website can be accessed via the internet at the following address:

https://yourevent.renaultgroup.com/defile_renault/index.html

Users will be able to register for one or more events for which they will be asked to complete a form. The information they provide must be accurate and complete.

Once the fields in the registration form have been completed, the User will receive confirmation by email.

The User undertakes to inform RENAULT immediately of any changes relevant to his/her participation in an event at the following email address: ledefile@event.renault.com.

Article 4 – Image rights

The participant(s) authorise(s) Renault, under the conditions described below, to use the videos and photographs in which they appear at this event.

Subject to their express consent obtained by ticking the box when registering for the event, the participant(s) authorise(s), free of charge:

- The reproduction of their image, their surname and their forename by any means whatsoever and on any present or future media, and/or any editing that may be done, it being specified that this authorisation includes the right on the part of the Organiser to make any addition, deletion, modification or dubbing to the initial recording of their image that is deemed useful, without changing the general spirit of the image; and
- The use of their image and/or the aforementioned editing as well as their forenames and surnames, in the context of the event, throughout the world, in all necessary formats and on present or future media (paper, graphic designs, videos, photos, digital, electronic, etc.) for the purposes of institutional promotion or internal and external communication, in particular for dissemination on le défilé Renault website as well as other websites published by Renault, on the websites of our partners, such as the

website and reports in which the image of the participant could be included in the press or on television.

- The use of their image and/or the aforementioned editing, on all present or future media (paper, graphic design, videos, photos, digital, electronic, etc.) for the purposes of institutional promotion or internal or external communication on the social media networks of Renault, its partners, the press and television media and influencers such as Facebook, Twitter or Instagram.

The aforementioned personal data may only be processed for these purposes for a period of one (1) year from the date of its collection.

Article 5 – Licence to use the Website

RENAULT grants the User a personal right to use the Website, the Content and its Elements, which is non-exclusive, revocable, non-assignable, non-transferable and free of charge.

This licence is granted to the User solely for his/her own needs, to the exclusion of any commercial or profit-making use of all or part of the Content and/or Elements.

The User acquires no other rights to the Website, the Content and/or the Elements other than those granted herein.

Article 6 – Obligations of the User

The User undertakes to use the Website in accordance with national and international regulations.

In particular, the User undertakes to:

- Read and comply with these TCUs,
- Not reproduce, even temporarily and/or partially, the Website and/or its Content, by any means and in any form,
- Not access and/or use the software components of the Website,
- Not use software or processes intended to copy the Content and/or likely to disrupt the proper functioning of the Website,
- Not adapt, modify, translate, transcribe, compile, decompile, assemble or disassemble all or part of the Website, the Elements and/or the Content,
- Not export the Website and/or merge it with other computer programs,
- Inform RENAULT if he/she becomes aware of hacking and/or illicit or non-contractual use of the Website and/or its Content,

- Not carry out any manipulation and/or introduce any virus or malicious code likely to cause computer and/or functional breakdowns liable to affect the proper functioning of the Website or of any Elements accessible via the Website,
- Not publish content and/or information that is irrelevant, subjective, excessive or insulting, use vulgar or offensive language, or share information that contravenes current regulations, particularly with regard to respecting the privacy of minors, • Hinder the proper operation of the Website by any means whatsoever,
- Harass, threaten, persecute, embarrass, spam or do anything inappropriate to another User, such as constantly sending unwanted messages, launching personal attacks or making statements about their ethnic origin, sexual orientation, religion, culture, etc. Hate speech will not be tolerated.
- Not post a message for any purpose other than personal communication. Prohibited messages include advertising, or any other type of solicitation or commercial activity.
- Not make inappropriate use of the help service or send false reports to RENAULT.

Article 7 – Site availability

RENAULT undertakes to do its utmost to ensure secure access to, consultation of and use of the Website.

The Website is accessible continuously, except in the event of force majeure or the occurrence of an event beyond RENAULT's control, and subject to any breakdowns and maintenance operations necessary for the proper functioning of the Website.

Article 8 – Liability – Guarantee

8.1 Use of the Website

To the extent permitted by applicable laws and regulations, RENAULT assumes no responsibility for the use of the Website by the User and makes no guarantee, express or implied, as to the speed or performance of the Website. In particular, access to the Website may be temporarily and periodically suspended for technical reasons; in such cases, the technical teams will make their best efforts to resolve the problem as quickly as possible.

RENAULT reserves the right to modify the information on the Website at any time and without notice. RENAULT cannot be held liable in this respect.

Access to and use of the Website are at the User's own risk. It is the user's responsibility to take all appropriate measures to protect their own data and/or software stored on their telephone and computer equipment against any cyber attacks.

In any event, RENAULT is released from all liability:

- In the event of non-compliance by the User with these TCUs;
- In the event of malfunction of the Website due to a cause, voluntary or involuntary, that is attributable to the User or to a third party or to malice, software, the smartphone/tablet in question, an interface or any other product of the User;

Other trademarks that may also be cited are used by Renault either with the authorization of their owner or simply as an indication of products or services offered by Renault.

Reproductions of the Content on a paper or computer-based medium are authorised, provided that they are strictly reserved for personal use, excluding any use for advertising and/or commercial and/or information purposes, and that they comply with the provisions of Article L122-5 of the French Intellectual Property Code.

With the exception of the above provision, the reproduction, imitation, use or affixing, by any process whatsoever and on any medium whatsoever, of all or part of the Content or all or part of the various works and models of Vehicles that make it up, without having obtained the prior authorisation of RENAULT or the holder(s) of the relevant rights, constitutes an infringement punishable by four years' imprisonment and a fine of €400,000.

Article 11 – Applicable law

The Website and these TCUs are governed by French law and shall be interpreted and applied in accordance therewith.

Attempts must be made to settle any dispute concerning the interpretation and/or performance of these TCUs out of court.

Failing an amicable settlement being reached, the dispute will be referred to the courts within the jurisdiction of the Paris Court of Appeal, to which the parties assign exclusive jurisdiction, notwithstanding multiple defendants or claims for compensation from third parties.

Article 12 – Updating the TCUs

RENAULT reserves the right to modify and update these TCUs without prior notice, at any time and without informing Users in advance.

Where applicable, changes and updates will be binding on the User as soon as they are published on the Website, and the User is responsible for consulting the current TCUs each time he/she logs on.

Article 13 – Miscellaneous provisions

13.1: No waivers

The fact that one of the parties does not take advantage of a clause in these TCUs shall not be interpreted as a temporary or definitive renunciation of the benefit of the provision in question, which shall remain in force.

13.2: Nullity of a clause

If one or more of the stipulations of these TCUs is declared invalid, null or non-existent given current regulations, a development or following a final decision by a competent court, the other stipulations will retain all their force and scope. The parties undertake to put in place a valid replacement provision as soon as possible, with an equivalent scope as close as possible to the spirit of these TCUs.

13.3: Force majeure

The following are expressly considered to be cases of force majeure, in addition to those usually accepted by the jurisprudence of French courts: bad weather, governmental and legal restrictions and modifications, computer breakdowns and telecommunications failures, failure of RENAULT's servers and any other event beyond the express control of RENAULT.
